PepsiCo Senior Notes Offering.

On February 13, 2023, PepsiCo, Inc. ("PepsiCo") announced an offering of \$350,000,000 of its Floating Rate Notes due 2026 (the "2026 Floating Rate Notes"), \$500,000,000 of its 4.550% Senior Notes due 2026 (the "2026 Notes"), \$650,000,000 of its 4.450% Senior Notes due 2028 (the "2028 Notes"), \$1,000,000,000 of its 4.450% Senior Notes due 2033 (the "2033 Notes") and \$500,000,000 of its 4.650% Senior Notes due 2053 (the "2053 Notes," and together with the 2026 Floating Rate Notes, 2026 Notes, 2028 Notes and 2033 Notes, the "Notes"). BofA Securities, Inc., Citigroup Global Markets Inc. and J.P. Morgan Securities LLC were joint book-running managers for the offering of the Notes.

PepsiCo received net proceeds of approximately \$2,983 million, after deducting underwriting discounts and estimated offering expenses payable by PepsiCo. The net proceeds will be used for general corporate purposes, including the repayment of commercial paper.

The Notes were offered and sold pursuant to a Terms Agreement (the "Terms Agreement") dated February 13, 2023 (incorporating the PepsiCo, Inc. Underwriting Agreement Standard Provisions dated as of November 18, 2019 (the "Standard Provisions")) among PepsiCo and the representatives of the several underwriters, under PepsiCo's automatic shelf registration statement (the "Registration Statement") on Form S-3 (File No. 333-266332), filed with the Securities and Exchange Commission (the "SEC") on July 26, 2022. PepsiCo has filed with the SEC a prospectus supplement, dated February 13, 2023, together with the accompanying prospectus, dated July 26, 2022, relating to the offer and sale of the Notes. The Notes were issued on February 15, 2023 pursuant to an Indenture (the "Indenture") dated as of May 21, 2007 between PepsiCo and The Bank of New York Mellon, as Trustee. The Indenture has been filed as Exhibit 4.3 to the Registration Statement. Opinions regarding the legality of the Notes are incorporated by reference into the Registration Statement and are filed with this Current Report on Form 8-K as Exhibits 5.1 and 5.2; and consents relating to such incorporation of such opinions are incorporated by reference into the Registration Statement and are filed with this Current Report on Form 8-K as Exhibits 5.1 and 5.2, respectively.
